#### Reorganization of Group Companies and Jurisdiction Change in Some Businesses

Daicel Corporation (Head office: Kita-ku, Osaka, President & CEO: Yoshimi Ogawa, hereinafter: "Daicel") will reorganize its Group companies and change jurisdiction of some businesses on July 1, 2020.

On April 1, 2020, Daicel changed its business structure from the conventional structure based on technologies and products to a system organized by "Strategic Business Units (SBUs), in order to further strengthen the "market-in" concept, focusing on target markets and customers. The reorganization in July of Group companies is also based on the "market-in" strategy, aiming to pursue synergistic effects in the marketing activities of business departments, and strengthen production department competitiveness in terms of production efficiency, product quality, and costs.

#### Summary of Reorganization and Jurisdiction Change

#### Integration of Three Group Companies into a New Company

Sales departments of the three Group companies listed above will be integrated into a new company named "Daicel Miraizu Ltd. (hereinafter: "Daicel Miraizu"), which will succeedDaicel FineChem .

The production departments of Daicel Polymer will be transferred to Daicel's Multiple Production Company, and Daicel Polymer will cease to exist. Daicel Value Coating's production departments will be a Daicel production subsidiary under the same name. Daicel Value Coating will be affiliated with Daicel's Multiple Production Company, working to further improve productivity in areas such as quality and costs.


