Reduction and Recycling of Industrial Waste

Daicel is a participant in the Keidanren Voluntary Action Plan on the Environment for a Recycling-Oriented Society. The Company has already achieved the Plan's target of reducing the amount of industrial waste disposal by landfill by 65% from the fiscal 2000 level by fiscal 2015. Daicel is therefore working on reductions based on its principle of no further deterioration going forward.

In fiscal 2014, the amount of industrial waste decreased by 2,500 tons compared with the previous fiscal year. In addition, landfill waste volume was reduced by 100 tons owing to recycling efforts and cuts in hard-to-recycle waste. The Company is working to prevent any increases in landfill waste.

1) 3R: Reduce, Reuse, and Recycle



The total amount of industrial waste generated by other Group companies increased by 200 tons from the previous fiscal year, and their disposal by landfill was reduced by 5 tons.

As a result of business expansion, industrial waste emissions increased by 2,200 tons at overseas Group companies, and disposal by landfill rose by 600 tons.

One of our medium-term targets is to achieve zero emissions at all business sites (landfill disposal less than 1% of industrial waste emissions). Out of six plants, three plants—Aboshi, Ohtake, and Harima—continued to have zero emissions in fiscal 2014.

Outside group companies Polyplastics Co., Ltd., Daicel Logistics Service Co., Ltd., DM Novafoam Ltd., Dainichi Chemical Corp., Daicel Pack Systems, Ltd. and Daicel Pyrotechnics Ltd. achieved zero emissions.

We will continue efforts to reduce disposal by landfill and achieve our medium-term targets.
